**Social norms and values:** Culture includes social systems, customs, and moral standards. In English, expressions like ‘cultural norms’ and ‘cultural diversity’ are commonly used.

There are also other related concepts in English. Terms such as ‘high culture’ and ‘low culture’ generally highlight differences in cultural expression across different social groups.

### 3. The concept of culture in the Uzbek language

In Uzbek, the term ‘culture’ (madaniyat) mainly refers to customs, traditions, moral values, art, and the results of people’s labor. Uzbek culture is founded on national values and historical traditions, containing many unique aspects. The concept of culture in Uzbek is commonly expressed in these forms:

**National customs and traditions:** Uzbek culture is often rooted in family and social traditions. The phrase ‘Uzbek national culture’ refers to the traditional lifestyle of the people, highlighting values like hospitality, respect, childrearing, and mutual support.

**Aesthetic and artistic expression:** In Uzbek, culture is also linked to art and literature. Phrases like ‘Uzbek literary culture’ or ‘Uzbek musical culture’ represent people’s aesthetic vision and artistic values.

**Social and moral values:** Uzbek culture includes traditional elements and embodies social norms and moral values. The term ‘civilized person’ usually describes someone who is respectful, polite, and morally upright toward others.



## 4. Comparison of the concept of culture in English and Uzbek

### Similarities:

- In both languages, culture includes values, customs, art, and social norms.
- Both cultures shape society's development and how its members interact.

### Differences:

- In English, culture is more linked to modern life and global connections. It highlights the interplay between values and cultural expressions on an international level.

- In Uzbek, culture is rooted in national, historical, and traditional values. Its uniqueness is closely tied to the social system and religious values of Central Asia.
