Frederic attempts to assert control over his life—through desertion, love, and protective care for Catherine—yet the surrounding world undermines these efforts. When Catherine dies during childbirth, Frederic laments, “I had no one to love or to love me. I could not believe it.” Hemingway uses this moment to illustrate the limits of human influence, emphasizing that existential confrontation with mortality and loss is inevitable, regardless of one’s intentions or desires.

War amplifies the novel’s existential themes, creating a context where human plans are constantly disrupted. The Italian front is portrayed as chaotic and arbitrary,



where life and death are dictated by random chance. Frederic observes, “The war seemed to me all wrong, but one had to live it and go through it,” acknowledging that survival often depends not on virtue or skill but on circumstance. This depiction reinforces Hemingway’s broader philosophical concern: human existence is precarious, and the struggle to find meaning occurs amidst forces beyond control.

Symbolism in the novel further illuminates these themes. Rain, recurring throughout the narrative, often accompanies moments of tragedy, such as Catherine’s final illness and the sense of inevitability surrounding death. Frederic reflects, “It seemed to me that life could not have been fairer, and yet it was so cruel.” The juxtaposition of hope and suffering underscores the existential tension between human aspiration and the randomness of fate, demonstrating that life’s meaning is negotiated within the constraints of uncertainty.
