JOHN DONNE (1572-1631)

Donne frequently employed "metaphysical conceits" — extended, surprising comparisons that connect distant or unrelated ideas. In poems such as "A Valediction: Forbidding Mourning", he compares lovers to the two legs of a compass, highlighting both unity and independence. Donne's religious poetry, especially in Holy Sonnets, explores themes of sin, repentance, salvation, and the human struggle with faith. His style is energetic, dramatic, and intellectually challenging, making him the leading representative of metaphysical wit.

GEORGE HERBERT (1593-1633)

George Herbert represents the more spiritual and devotional side of metaphysical poetry. A priest and deeply religious writer, Herbert used poetry as a medium to express his relationship with God. His works are known for their sincerity, humility, and structural creativity.





Herbert often experimented with poetic form to reinforce meaning. For example, "The Altar" and "Easter Wings" use visual shapes to reflect their themes. His language is simple yet profound, blending emotional devotion with metaphysical reflection. Unlike Donne's dramatic tone, Herbert conveys calmness, purity, and inner contemplation.

ANDREW MARVELL (1621-1678)

Andrew Marvell stands between the spiritual seriousness of Herbert and the bold intellectualism of Donne. His poetry combines political commentary, philosophical meditation, and delicate lyricism. Marvell's famous poem "To

Coy Mistress" illustrates carpe diem philosophy, exploring time, desire, mortality, and the fleeting nature of life.

Marvell's metaphors are both vivid and subtly ironic. He deals with themes of nature, love, and human existence with clarity and elegance. His balanced style makes him one of the most versatile metaphysical poets.

CHARACTERISTICS OF METAPHYSICAL POETRY

The works of Donne, Herbert, and Marvell share several defining features: Metaphysical conceits: elaborate and surprising metaphors linking distant ideas. Intellectual depth: poems require reflection and reasoning rather than simple emotional response. Philosophical and spiritual themes: discussions of life, death, the soul, time, love, and the divine. Conversational tone: direct address to the reader or a silent listener. Blend of emotion and logic: strong feelings expressed through rational argument.
